- 2. Day 1A Structure
 - a. \$35 Buy-in
 - b. Only Bar Poker Open Championship Invited Players are eligible to compete in this tournament.
 - c. Sign-up begins Friday, December 2nd 6PM and ends after Level 4 of Day 1A.
- 3. Day 1B Structure
 - a. \$145 Buy-in + \$35 Entry
 - b. Only Bar Poker Open Championship Invited Players are eligible to compete in this tournament.

- 4. Late Registration Open 4 Levels. Players registering late will be sold full stacks.
- Levels will last thirty (30) minutes each.
- Ten (10) minute break after Levels 7, 12, 16, and 20 6.
- 1:10 Players will bag their chips and advance from each Day 1A and Day 1B to Day 2
- 8. Day2 Structure
 - Only qualified players advancing from Day1A and Day1B are eligible to compete with their acquired chip stacks from their respective Day1.
 - Levels will last thirty (30) minutes each.
 - The starting Blind Level will be the lower of the two final Levels from Day1A and Day1B.
 - Tournament will break upon reaching the Final eight (8) players and resume at 6PM for Final Table Live Stream.
- 9. Tournament Director or Floor decisions are final and without recourse.
